The event offers family, friends and the general public plenty of entertainment, including live music, free drinks and, of course, a sampling of the dishes that are prepared on site.

Although teams are not limited in what particular dish they prepare, teams will compete for "Best Local Favorite", "Best Dessert", "Most Creative", "Best Booth Decoration", "Crowd Favorite" and "Best Overall" titles awarded by distinguished local judges.

The event will help raise money for Southeast Louisiana Legal Services, a nonprofit corporation that serves individuals and families who, without legal assistance, would lose a critical human need – food, shelter, income, medical care, personal safety or parental care. The **New Orleans Bar & Grille** is a unique opportunity that brings the legal community and private business together for this worthwhile cause.

Cost for team participation is only \$150 or \$175, depending on whether or not electricity is needed, and includes entry for a three-member team of chefs. Further details and complete rules and regulations will be provided upon registration. General admission for the public is \$25 per person donation in advance and \$30 at the door (children under 12 free with an adult).
